 - Next steps: Need to lay out format of evening, length of time for each performer, secure emcee, corporate sponsorships
 - Corporate sponsors discussed: Simsbury Bank (confirmed), Hartt (pending) Hoffman, Pride, Paines, Max Restaurant Group, Mitchell, Shop Rite and Chubb
 - Excel sheets for corporate sponsor solicitation and volunteer committees are posted on Google docs – links will be sent out
 - Angela will coordinate securing performers.
 - We will feature Virtuoso and Maestro level sponsors in our media ads for the event and on a poster board at the event. Business partners who donate at the Musician level up to \$500 will be listed in the program and on a poster board at the event. Businesses can donate an auction item if they are not able to donate monies.
 - Impact of cancellation was reviewed, no obligation beyond deposit up until 30 days before event. Event can be modified in catering, etc based on number of tickets sold. Will be reviewed at 30 days and 14 days.
 - Google docs are made for corporate sponsors, auction items, and committee volunteers.
